Writing for the United State Supreme Court in 1974, Justice Lewis Powell stated that there is no such thing as a false idea. Has the promise of that statement been fulfilled?

On November 6-7, 1987, the conference LIBEL ON THE EDITORIAL PAGES will look at the liability that newspapers face for publication of material on the editorial pages. Discussions will focus on the problems encountered in publishing editorials, editorial cartoons, letters to the editor and syndicated opinion columns. Presentations by editors, lawyers, cartoonists, legal and journalism academics, and others will examine the judicial treatment of editorial page libel claims and the effects of such claims on editorial practices. This conference, held at the Marshall-Wythe School of Law at the College of William and Mary, is presented by the Institute of Bill of Rights Law, with the co-sponsorship of the American Newspaper Publishers Association, the Association of American Editorial Cartoonists, the National Conference of Editorial Writers and the American Society of Newspaper Editors.

The Institute of Bill of Rights Law was established at William and Mary in 1982 to support scholarly research on the Bill of Rights, particularly the First Amendment. The Institute sponsors programs to facilitate interaction between the professions of law and journalism. The Institute of Bill of Rights Law was established by a bequest of Laura Lee, who held a lifelong interest in a free press and its role in our society, in memory of her parents, Alfred Wilson Lee and Mary I. W. Lee.
