## FIFTH ANNUAL TIDEWATER TAX CONFERENCE

Arrangements have been completed for the Tax Conference to be held in the Phi Beta Kappa Hall on the campus at Williamsburg on Saturday, December 12, 1959. Information concerning the program content is attached. Printed copies of the program with registration cards are now being mailed.

## FACULTY ACTIVITIES

President Chandler has appointed a Law Library Committee consisting of Professors Atkeson, Cormack and Phelps as Chairman. This Committee is establishing improved methods of obtaining additional acquisitions of basic materials and other items.

Professor Thomas C. Atkeson addressed the Peninsula Chapter of the Virginia Society of Certified Public Accountants in Newport News on October 21, 1959, with reference to the aims and objectives of the Fifth Annual Tidewater Tax Conference.

Professor Arthur W. Phelps attended a meeting of the Committee on Continuing Legal Education in Charlottesville, Virginia, on October 24, 1959.

Professor Phelps' book, "Handbook of Virginia Rules of Procedure in Actions at Law" is now available and is being used by the students in the course in Virginia Procedure.

Professor James P. Whyte, along with law professors from New York University, University of Colorado, Harvard, Rutgers, the University of Kansas, Wayne State, and George Washington University, has been named to the Committee on Continuing Legal Education of the Association of American Law Schools.

Professor Whyte addressed the Junior Chamber of Commerce of Williamsburg at its October dinner meeting on the topic of ORGANIZATIONAL PROBLEMS OF LABOR. He traced the rise of labor unions on the basis of national legislation, and discussed problems likely to be encountered by employers as the South becomes more industrialized.

## STUDENT ACTIVITIES

Lockers for law students have been installed in the area adjacent to the Library.

A legal film program has been initiated by the Student Bar Association. Movies will be shown each Monday and Wednesday for the remainder of the semester. Many aspects of the law are covered. Funds will be available to continue the program into the spring semester if interest justifies it.
