THE SUMMER SCHOOL OF LAW IN ENGLAND — ITS ORIGIN AND PURPOSE

The College of William and Mary in Virginia has had significant relationships with England throughout its two hundred seventyseven year history. The College was chartered in 1693 by the reigning sovereigns, William and Mary, whose name it bears. The College's first building was constructed 1695 from plans attributed to the renowned English architect, Sir Christopher Wren, builder of St. Paul's Cathedral in London. Through the efforts of Thomas Jefferson, an alumnus of the College, a chair of Law and Police was established December 4, 1779, thus making William and Mary the first to offer instruction in law in the United States.

In more recent years the College's continuing relationship with England and its educational institutions has been evidenced by an active student and faculty exchange program, and by establishment of the Summer School of Law in England in 1967 on the campus of the University of Exeter in Devonshire.

Newly constructed dormitories, dining hall, and the classrooms of Exeter's Crossmead Hall campus, as well as the law library of the University, were made available. In addition, distinguished members of the faculty of the University's School of Law agreed to teach some of the courses offered. The program has been further enriched by prominent speakers from the English Bench and Bar, as well as by visits to the Inns of Court, to English courts when in session, and to historic landmarks in the development of Anglo-American law — Runnymede, Westminster Hall, the Star Chamber, Parliament, and Old Bailey.

Since American and English legal systems developed from the same cultural history, one of the primary advantages of the program is the opportunity to enrich understanding of American legal institutions by a comparison with the English legal system. Emphasis is also placed on English legal history and international law.

The fifth session of the Summer School of Law in England will be conducted from July 5 to August 13, 1971.

CURRICULUM AND CREDITS

The Summer Law School in England, as an extention of the Williamsburg campus, is fully accredited. The 1971 program will consist of one six-week term with courses of 2 and 3 semester hours. Class meetings and duration of classes will be in accordance with the requirements of the American Bar Associaton and the Association of American Law Schools and regular class attendance will be expected. A course load not in excess of seven semester hours is recommended. Residence credit will be given commensurate with the number of semester hours credit carried. The Marshall-Wythe School of Law will give the same credits as if the course were being of-fered on the Williamsburg campus. All other law schools having students at the four previous sessions have approved the transfer of credits for the courses taken by their students.

LIVING FACILITIES

There are separate residence facilities for men, women, and married students in the dormitories on the campus. Faculty and students take their meals at the dining hall near the dormitories. The available dormitory and classroom facilities limit the total number of Summer Law School students to one hundred.

In the past special arrangements have been made by married students with families to lease apartments and houses in Exeter.

RECREATIONAL OPPORTUNITIES

The cultural opportunities attending the program of Summer School of Law in England are suited to every taste. In addition to travel opportunities, Exeter is an attractive and ancient cathedral town only a few miles from the excellent beaches of South Devon coast. Direct, fast train service to London is available several times daily. Tennis, golf, sailing and other athletic facilities are available

SCHEDULE OF COURSES IN AMERICAN, ENGLISH AND COMPARATIVE LAW

Courses will be taught by members of the faculties of the Marshall-Wythe School of Law and the University of Exeter. The fol-

lowing courses are tentatively scheduled for the 1971 program. Courses meeting 80 minutes daily carry three semester hours credit.

ELIGIBILITY

The program of the Summer School of Law in England is open to any American law student, over the age of twenty-one years, in good standing at a law school approved by the American Bar Association. It is also open to graduates of approved law schools wishing to extend their studies in the courses offered. Normally, an applicant will have completed or be in the process of completing at least one year of law study. In applying for the 1971 summer program, an applicant must submit, with the application, a certificate of good standing from his law school regularly attend-

ed, or evidence of graduation from an ABA-approved law school.

The registration fee is payable upon filing the application fee. It will be refunded only in the event that the application is not accepted due to full enrollment.

DEADLINES FOR APPLICANTS

March 15, 1971 - Last date for submitting applications. Because of the limited enrollment, however, it is recommended that applications be filed well in advance of this date since, in fairness, they will be processed and qualified applicants accepted in the order their applications are received. The forms on the last two pages of this Bulletin should be used.

April 15, 1971 - Payment of \$265 for room and board at Crossmead. This payment is not refundable unless a waiting-list applicant purchases the accommodations.

May 15, 1971 - Full payment of tuition. Tuition is refundable thereafter only if applicant is unable to attend for verified reasons of sickness or military service obligation.

June 1, 1971 - Full payment of airline group round trip ticket. Not refundable or transferable.

TRANSPORTATION

The College of William and Mary accepts no responsibility for transportation of participants in the program of Summer School of Law in England. It is anticipated, however, that low group-fare flights will be arranged on a regularly scheduled airline. As plans for such flights materialize, a special information sheet will be sent to applicants. The 1970 group-fare roundtrip flights were arranged at a cost of approximately \$250 per person. This figure may be used as a general estimate of the probable cost for a similar flight in 1971, but is subject to change if the fares for group flights are raised or lowered by the airlines. Spouses and dependents traveling with students will be entitled to the same low group-fare.

One group flight will leave Washington (Dulles) about July 1, 1971, and will return from London on or about August 23. To accommodate those students who want more time to travel in England and on the Continent a second group flight will be arranged to leave Washington (Dulles) on or about June 15, 1971, returning from London on or

about August 31.
