Michael Gerhardt

Michael Gerhardt is currently the Arthur B. Hanson Professor of Law at William & Mary Law School. He has written over 50 law review articles and essays on various topics in constitutional law, including most recently *Attitudes about Attitudes* in the Michigan Law Review, *The End of Theory* in the Northwestern University Law Review, and *The Constitutionality of the Filibuster* in Constitutional Commentary.

He is the author of several books, including The Federal Impeachment Process: A Constitutional and Historical Analysis (2d ed. 2000, University of Chicago Press) and The Federal Appointments Process (rev. ed. 2003). He also wrote the book, Constitutional Theory: Arguments and Perspectives (2d ed. 2000), with Professors Thomas D. Rowe, Jr., of Duke Law School, Rebecca Brown of Vanderbilt Law School, and Girardeau Spann of Georgetown University Law Center. Professor Gerhardt has consulted with members of Congress on many issues and testified numerous times before the Congress, including as the only joint witness in the House Judiciary Committee's historic 1998 hearing on the scope of impeachable offenses and in the summer of 2003 as an expert on the constitutionality of the filibuster before the Senate Rules and Judiciary Committees.

During the summer of 2003, the Democratic Caucus of the United States Senate invited him to speak on the constitutionality of the filibuster. In 1992/93, he served as a special consultant to the National Commission on Judicial Discipline and Removal and the Presidential Transition, and in 1994 he assisted the White House on the nomination of Stephen Breyer to the Supreme Court. Professor Gerhardt's honors include his selection as the inaugural lecturer in the James R. Browning Distinguished Lecture Series at the University of Montana School of Law in 2002 and as the Alpheus T. Mason Lecturer at Princeton University in October 2003. While on leave in the spring of 2004, Professor Gerhardt will serve as a visiting fellow in the Politics Department at Princeton University.
