## Online Self-Grading Assessments for Legal Research and Writing Courses

The chart below identifies free and subscription-based resources covering legal research and writing topics. It discusses only online resources with pre-built exercises and quizzes that provide instant feedback and explanations to students. The chart organizes the online resources into three broad subjects: legal research, legal writing, and legal citation.

By assigning these resources, professors can assess student performance without increasing the professor's workload. Importantly, the time needed for students to complete any online exercise counts toward the required ABA instructional minutes and out-of-class minutes.
