#### LINDA A. MALONE

Linda Malone is the Marshall-Wythe Foundation Professor of Law and Director of the Human Rights and National Security Law Program at William & Mary Law School. She is a member of the American Law Institute, the Environmental Commission of the World Conservation Union, and the Review Board of the Land Use and Environmental Law Review. She serves on the Board of Directors for the International Society for the Reform of Criminal Law and the American Association of International Criminal Law. She has authored or co-authored 12 books on environmental law, international law, and human rights, including *Defending the Environment: Civil Society Strategies to Enforce International Environmental Law*, and the preeminent book on the intersection of environmental law and land use, *Environmental Regulation of Land Use*.

Professor Malone was a delegate to the United Nations Conference on the Environment and Development in Rio in 1992, cocounsel to Bosnia-Herzegovina in its genocide case against Serbia and Montenegro before the World Court, co-counsel to Paraguay in its challenge to the death penalty in Paraguay v. Virginia, and co-counsel for amici in the Supreme Court in Padilla v. Rumsfeld and Hamdan v. In 1998 she received the Fulbright/OSCE Regional Rumsfeld. Research Award for her work on women's and children's rights in Eastern Europe, and in 2007 she was awarded a grant from the National Endowment for the Humanities, State Department, and International Research and Exchange Board to continue this work. She received the Millenium Award of the Virginia Women's Bar Association in 2000 for contributions to women's rights. She has also served on several committees of the National Academy of Sciences and co-authored the report of legal experts for the U.S. Ocean Commission in 2005.

Professor Malone received her B.A. from Vassar, her J.D. from Duke, and her LL.M. from the University of Illinois.
