We have helped hundreds of veterans, in specific cases securing fair disability compensation and medical benefits, accurate diagnosis of service-related injuries, helpful psychological and social counseling and even treatment that got them back to work.

We are expanding the network of professionals committed to this growing need. In addition to providing actual case experience for students at the W&M Law School and VCU, we have formed alliances for training and outreach with the Virginia Bar Association, the McGuireWoods Law Firm and Veterans Service Organizations.

The clinic also trains interested private attorneys who want to serve veterans on a pro bono basis.





## LEWIS B. PULLER JR.

Marine Lt. Lew Puller lost both legs and parts of both hands in Vietnam in 1968. After years of rehabilitation, he earned a law degree at William & Mary and worked as an advocate for veterans. His Pulitzer Prizewinning autobiography, "Fortunate Son," chronicled his struggle to overcome physical and emotional injuries and his battle with alcohol, painkillers and depression, which finally claimed his life.




### KEEPING AMERICA'S PROMISE

## WHO ARE OUR CLIENTS?

Veterans from World War II to the current conflicts in Iraq and Afghanistan come to our clinic for help. Many are indigent and homeless. Some have complex legal issues. Many have hit a stone wall in the benefits process.

We provide legal services at no charge. For those who need financial assistance, our representation also includes the cost of medical evaluations and related transportation.



### WHAT ARE THE CLINIC'S PLANS?

To help meet the surge in veterans' claims nationwide, the Puller Clinic and VCU's Center for Psychological Services and Development have expanded their model by forming a consortium of specialists under the name Helping Military Veterans through Higher Education.

Today, HMVHE ("Humvee") brings together Virginia's colleges and universities to provide life-changing assistance to veterans while educating tomorrow's professionals with real-world clinical experience. After showing statewide success, the objective will be to replicate the model nationwide.
