
Law School's Alumni Weekend a Virtual Success

Though the usual return to campus wasn't possible due to the ongoing pandemic, alumni from the classes ending in 0s and 5s and 1s and 6s were able to catch up with classmates and friends during a six-day virtual Alumni Weekend on April 9-14.

Classes ending in 1s and 6s raised close to \$2.3 million in gifts, multi-year pledges and planned gifts by April 10. To date, the collective impact of the past two reunion cycles (the 1s and 6s in 2021 and the 0s and 5s in 2020) amounted to almost \$3.2 million in support of the Law School. That number will continue to increase until the fiscal year ends on June 30. In addition to reunion celebrations, there were plenty of other fun and educational virtual events.


us to not just lament the lack of diversity around us, but actually to take ownership of the issue and invest in it as game changers." [Read more.](#)


