

The Menzies Lectures

The Menzies Lectures were established by the Sir Robert Menzies Memorial Trust in honor of the Late Prime Minister of Australia who was a Visiting Scholar at the University of Virginia Law School during 1966-67. While at Virginia, Sir Robert delivered a series of lectures on "Central Power in the Australian Commonwealth." Subsequently, the Menzies Lectureship was created to provide an annual exchange of distinguished Australians and Americans. The lecture alternates each year between the two countries. Lectures in Australia are delivered in Canberra at the Australian University, and in Melbourne. Lectures in the United States are given both at the University of Virginia and at the College of William and Mary.

Sir Ninian Stephen, former Governor-General of Australia, delivered the most recent Menzies Lecture in October of 1989. Last year, former Dean William B. Spong, Jr. was the third Menzies lecturer from the United States.

Professor Donald W. Greig

Professor Donald W. Greig is a member of the law faculty of the Australian National University. From 1977 to 1980 and from 1988 to 1991, he was dean of the faculty of law.

Professor Greig was educated at Cambridge University (B.A., M.A., LL.B) and at the Australian National University (LL.D.).

Professor Greig has published widely in the field of international law. His work includes a standard text in international law as well as numerous articles in scholarly journals published in Australia and abroad. Professor Greig is also recognized as an authority on contracts and commercial law. He has published standard works on contracts, commercial law and the sale of goods.

Professor Greig has held visiting faculty appointments at universities in Australia, England, Wales, and Canada. He is currently editor of the *Australian Yearbook of International Law*.
