Topic

The issue of reporting lawyer misconduct continues to attract the attention of both the public and the State Bar. The issues are complex, merging as they do the lawyer's duty to clients, the public, and the profession. State Bar rules have been amended and further changes continue under consideration and debate. Without an effective response by the profession, external controls will likely be implemented.

Seminar Format

Following a brief lecture, participants will interview an individual playing the role of a client or other source of information. This individual will have knowledge of acts of another lawyer that may be characterized as misconduct. The participant will analyze the situation and determine a course of action. Group discussion will then focus on and explore the responses proposed by the various participants.

Mary. Professor Moliterno is director of the program and Professor Levy is a member of the program's governing executive committee. Together they are the authors of a book entitled "Ethics of the Lawyer's Work" (West, 1993).

Professor Levy is a member of the Virginia State Bar's Special Committee to Study the Code of Professional Responsibility. Professor Moliterno has taught courses in legal ethics and lawyering at four law schools and is co-author of a book entitled "An Introduction to Law, Law Study, and the Lawyer's Role" (Carolina Academic Press). In addition, he has authored several journal articles on the teaching of lawyering and legal ethics.
