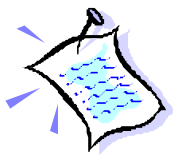

NEWSWORTHY NEWS

CONGRATULATIONS to the William & Mary Law School Trial Team for their first place finish this past weekend at the National Pretrial Competition hosted by Stetson Law School in Florida. The students at this tournament competed in brief writing, motion arguments, an evidentiary hearing, and final arguments (all organized around a civil trial). The tournament consisted of four rounds: round 1, round 2, semifinals, and finals. The W&M team, comprised of Brian Cannon, Johanna Orleski, Rustin Mangum, and Amanda Ritucci-Chinni, won the overall competition.

A "best advocate" winner was also selected from all of the competitors in each of the four rounds. A W&M team member was named "best advocate" in three of the four rounds: Brian Cannon was named "best advocate" in round 1; Johanna Orleski won "best advocate" in both the semi-finals and finals.

The W&M Trial Team has gained a reputation in recent years as a national powerhouse. The Stetson victory further bolsters that reputation. Many thanks to Trial Team coach, Jeff Breit, for his continued outstanding work with our students.

a) Monday, October 18: Avalon Center for Women and Children Program: 12:50-1:50 p.m., in Room 120: General Information Session about Avalon Center, issues of domestic violence and sexual assault (including statistics, legislation, law enforcement, and psychological impact).

7:00 PM: "In Her Shoes" Program in Room 119: An experiential real-world workshop that builds upon the experiences of seven characters who are experiencing domestic violence and poverty. This interactive educational tool demonstrates the complex ways in which lack of money and access to other resources impact domestic violence survivors and their children. Once participants are faced with making the same gut-wrenching choices that survivors are forced to make, they develop an understanding of why there must be a stronger safety net in place for

women and their children. Program participants are often motivated to engage in local problem solving.
