FACULTY ACTIVITIES

As a member of the Virginia State Chamber's Tax Study Committee, Professor Atkeson accompanied the Chamber's President, Clem D. Johnston, in the personal presentation of the Report to Governor Harrison on March 15, 1962. This report will serve as background for the Governor's Tax Study Committee authorized by the 1962 General Assembly.

Professors Arthur W. Phelps and James P. Whyte attended a meeting of the Virginia Trial Lawyers Association in Charlottesville on February 18th.

As one of the advisers to the Committee of the Virginia Bar News, Professor Phelps met with the Committee on March 29th in Charlottesville to discuss the question of the appointment of a new editor and other matters relating to this publication.

A revision of COHEN'S DIVORCE AND ALIMONY IN VIRGINIA AND WEST VIRGINIA by Professor Phelps is in the hands of the publisher and will be published at an early date.

It is expected that an appendix will be included with forms drafted by an attorney practicing in both states.

Dr. William F. Swindler is co-author, with Dr. A. Hughlett Mason of Arlington, of an article on the Mason-Dixon line which has been accepted for publication by American Heritage magazine.

LAW LIBRARY

Several hundred volumes, primarily session laws and state reports which have long been out of print, have recently been added to the law library collection. They were acquired on an exchange arrangement with the Library of Congress. Negotiations are currently in progress with law libraries in various parts of the country with reference to exchange of duplicate materials.

SUMMER EMPLOYMENT PROGRAM FOR HONOR LAW STUDENTS

The Chief Counsel's Office of the Internal Revenue Service will conduct its first summer employment program for honor law students this year, with only fifteen to be selected throughout the country. Rexford R. Cherryman, currently in the Master of Law and Taxation program and Editor of the 1962 Law Review has been selected by the Chief Counsel as one of the fifteen participants.

STUDENT ACTIVITIES

The American Law Student Association held its annual regional convention in Washington, D. C., March 23-25, 1962, composed of law schools from the Third, Fourth and Eleventh Judicial Circuits. The Marshall-Wythe School of Law was represented by Owen Knopping, and Edmund Walton. Mr. Knopping was last year's **Deputy-Vice-Justice** of the Fourth Circuit, a position to which he was elected in the Regional Conference of 1961. The purpose of the convention was to collect ideas from representative law schools so that each law school may have a more efficient Student Bar Association and a better insight into the study of law.

Of particular interest is the recent initiation of a "Better Speakers Club." Patterned after the well-known Toastmasters Club, its aim is to give those law students who wish to develop their poise and skill in oral presentation an opportunity to speak extemporaneously on any subject. The interest shown thus far indicates that the club is off to an excellent beginning. All law students are invited to attend the meetings which are held at 9:00 o'clock each Friday morning.

At the suggestion of Dr. Joseph M. Cormack, the newly organized publicity committee of the Student Bar Association is exploring the possibility of publishing a series of short articles concerning the current activities of some of our alumni including a brief biographical sketch of each for the Alumni Gazette. It is hoped that such plans can be formulated for presentation to the William and Mary Law School Association at its annual meeting on May 5, 1962.

Approximately seventy-five delegates and law professors from law schools in the southeastern United States will be in attendance. The banquet speaker will be E. Barrett Prettyman, Jr., author of DEATH AND THE SUPREME COURT.
