**ABA RE-ACCREDITATION PROCESS BEGINS** - Every seven years, each ABAaccredited law school must go through a re-accreditation process. Re-accreditation ensures that our graduates are eligible to take the bar exam anywhere in the United States. The re-accreditation process involves a detailed Self-Study and compilation of data, followed by a site visit by a team of ABA accreditors. William & Mary's site visit team will arrive in October 2009. Between now and then, faculty, administrators, and students will be asked to contribute thoughts and ideas to the Self-Study. You will be hearing more about this throughout the year. The Self-Study Committee is chaired by Professor Barnard and includes Dean Kaplan; Professors Banks, Heller, Heymann, Marcus, Meese, Roberts, and Ward; and students Latoya Asia (3L) and Rob Poggenklass (2L).

**VIRGINIA BAR UPDATE** - The Application for the Virginia Bar Examination and the Applicant's Character and Fitness Questionnaire are available online through the Virginia Board of Bar Examiners web site at: <u>http://www.vbbe.state.va.us/forms.html</u> Students who expect to sit for the Virginia Bar Examination can file the Character and Fitness Questionnaire within the first 14 months of their law school career for a discounted rate. The Bar Application itself cannot be filed more than three months prior to sitting for the exam.

Those planning to sit for the Virginia Bar are forewarned that the Virginia Board of Bar Examiners requires applicants to take the Multi-state Professional Responsibility Examination (MPRE). The MPRE is a fifty question, two-hour, multiple-choice examination administered three times each year. **Deadline for "Early Decision" Public Interest and Government Summer 2008 Funding for 2Ls:** Funding through eight programs (Bell, Christopher Wren Association, Dean's Fellowships, Pinter Fellowships, Virginia State Bar Criminal Law Section, Virginia Law Foundation, Public Service Fund [PSF], and Williams) is available through an "early-decision" process, which gives 2Ls the opportunity to know about funding decisions before the end of the fall semester. **The application deadline for "early decision" funding is Friday, November 21 at 5:00 p.m.**  *Fax Machine:* A fax machine is available in the Office of Career Services for students' law school-related matters, such as job searches, bar applications, and coursework.
