

Judicial Independence and the Separation of Powers - Come hear attorney David Baugh's presentation "Judicial Independence and the Separation of Powers" on Friday, October 31st, at 10:00 a.m. in room 124. Mr. Baugh, who practices law in Richmond, Virginia, is one of the most controversial lawyers in the U.S. The son of a Tuskegee Airman, he often represents controversial clients in constitutional law cases, such as Ku Klux Klan Grand Dragon Barry Elton Black, and embassy bomber Mohamed Rashed Daoud Al-Owhal. Mr. Baugh is a staunch advocate of First Amendment rights who works closely with the ACLU. Alan Dershowitz has written that Mr. Baugh deserves a place of honor in the pantheon of free-speech heroes. There are seven **Fellowship Programs** that provide stipends of up to \$3,000 for students who secure summer internships with employers who are unable to provide funding or can only provide partial

funding. The availability of funds through William & Mary enhances your candidacy with employers. There is a one-page handout available on the display racks in OCS that describes William & Mary's various Fellowship Programs for the summer of 2004. Please feel free to include this flier with your resumes and cover letters to government and public service employers. In your cover letter, you may want to indicate that "William & Mary has several public interest [or government] summer funding sources, as detailed on the enclosed sheet." The application process for these fellowships is very competitive, and you must have a written offer of employment in order to apply for funding. 2Ls Please NOTE THE MESSAGE BELOW ABOUT THE "EARLY DECISION" PROCESS.

Deadline for "Early Decision" Public Interest and Government Summer 2004 Funding for 2Ls - Funding through six programs (Bell, Criminal Justice, Lambda, Virginia Law Foundation, Public Service Fund [PSF], and Williams) is available through an "early-decision" process, which gives 2Ls the opportunity to know about funding decisions before the end of the fall semester. The application deadline for "early decision" funding is Monday, November 18 at 5:00 p.m.

PSLawNet - William & Mary's law school subscribes to the **Public Service Law Network Worldwide**, which gives students special access to a searchable database of thousands of government, public service and *pro bono* opportunities worldwide. You can find positions in many practice areas, including criminal law, tax law, housing, AIDS/HIV issues, bankruptcy, women's issues, civil liberties, entertainment and more. Hundreds of paid jobs and fellowships are also listed. Just go to www.PSLawNet.org to register and start searching; there is also a handout in OCS with tips for searching the web site. The service is free to W & M students.

Judicial Clerkship Institute - In order to improve the effectiveness and efficiency of judicial clerks, Pepperdine University School of Law in Malibu, California, will sponsor the Judicial Clerkship Institute January 2-4, 2004. The faculty of the Institute – all federal judges – will give students much of the practical knowledge every law clerk needs. Any law student who has been selected for a federal judicial clerkship (and has received permission to attend from his or her judge) is eligible. Tuition is \$95, and most meals are included; shared hotel accommodations are \$125 for three nights (or \$350 for a private room). For more information, see OCS or law.pepperdine.edu. Space is limited, so apply early. The deadline for application and fees is December 1, 2003.

More Judicial Clerkships for 3Ls - OCS has prepared a handout listing literally hundreds of state court and federal specialty court clerkships that are still available to 3Ls. Stop by and pick up a copy.

Fax Machine - A fax machine is now available in room 263E of the Office of Career Services for student's law school-related matters, such as job searches, bar applications, and coursework. Use of the machine is free for current students. Students have access during all the hours OCS is open – that is, the same hours as the library circulation desk. The machine may be used for outgoing faxes only; use is governed by the Honor Code. Instructions are posted next to the machine.

NEW RESOURCES IN OCS

Corporate Law - The **Corporate Yellow Book** lists contact information for more than 41,000 executives at over 1,000 companies and 5,000 subsidiaries and divisions, and more than 9,000 board members and their outside affiliations. **Most listings include** the names of the firms who serve as outside general counsel to the companies.

Federal Government - The **Federal Yellow Book** includes contact information for over 40,000 government officials in the Executive Office of the President, 15 Cabinet-level departments, and more than 80 independent federal agencies.

Interviewing - Why are beer cans tapered at the top and bottom? How many piano tuners are there in the world? Why do mirrors reverse right and left instead of up and down? According to the dust jacket for **How Would You Move Mount Fuji?**, "For years Microsoft and other high-tech companies have been posing riddles and logic puzzles like these in their notoriously grueling job interviews. Now 'puzzle interviews' have become a hot new trend in hiring." The book poses questions, posts answers, and tells how to outsmart the puzzle interview.

WRITING COMPETITIONS

Note: Throughout the academic year we receive announcements regarding essay competitions and invitations to submit papers for publication in law reviews and journals. This information is posted on the bulletin board in OCS, with additional information filed in the Applications Cabinet. In addition to the intellectual and often monetary benefits of these contests, the competitions are another way for you to demonstrate your legal writing abilities to prospective employers. Because they are often sponsored by bar associations and other professional groups, they also provide excellent networking opportunities. Keep in mind that faculty members are a good source of ideas and guidance.

Environmental Law - The William & Mary *Environmental Law and Policy Review* is seeking papers on any environmental law topic. The top paper will be awarded \$250. **Entries must be received by November 30, 2003.**

Clear Writing - Legal Affairs magazine and The Marbury Institute of Piper Rudnick LLP is sponsoring the First Annual Legal Affairs Writing Contest for Law Students. The competition promotes clear, accessible writing about the law and provides a chance for students to have a work published. Students are asked to make an argument of no more than 1,500 words about a pertinent topic in the law, written in a style that's accessible to general readers and lawyers alike. The first-place winner will be awarded \$2,000, and his or her entry will be published in Legal Affairs in the spring. Second prize is \$1,000 and third prize is \$500. Entries are due January 7, 2004.

Bioethics - The **American College of Legal Medicine** will present a first prize of \$1,000 (and \$500 and \$250 for second and third place, respectively) to a law student for the best paper on any legal aspect of bioethics. All papers submitted will receive consideration for publication in the *Journal of Legal Medicine* or other medical legal publications, and **must be received no later than January 19, 2004.**

Employment and Labor Law - The 2003-2004 Louis Jackson National Student Writing Competition in Employment and Labor Law is seeking papers on any topic relating to the law governing the workplace, such as employment law, labor law,

employee benefits, or employment discrimination. ONLY THE FIRST TWO SUBMISSIONS PER LAW SCHOOL WILL BE ACCEPTED AS ENTRIES FOR CONSIDERATION. One award of \$3,000 and two \$1,000 awards will be presented to the top three entries, and all three will be published. *The deadline for submission is January 19, 2004*.

Legal Medicine - The American College of Legal Medicine will present the \$1,000 Letourneau Award to a law student for the best paper on any legal aspect of medical science, medical practice, or other health care delivery problem. All papers submitted will receive consideration for publication in the Journal of Legal Medicine or other medical legal publications, and must be received no later than January 19, 2004.

Health Law - Epstein Becker & Green, a national firm engaged in the practice of health law, announces its sixth annual **Health Law Writing Competition** for papers on current topics of interest relating to health law. Papers may address any traditional area of the law as applied to health care (*e.g.*, antitrust, tax, corporate), or areas of law unique to health care (*e.g.*, fraud and abuse, managed care, Medicare/Medicaid). First prize is \$4,000, second prize is \$2,000, and third prize is \$500. **Competition entries are due January 19, 2004.**

Race and Ethnicity - The Second Annual LatCrit Student Scholar Program seeks applications from students. "Latino/a Critical Theory (LatCrit) is a scholarly movement designed to respond to the long historical presence and general sociolegal invisibility of Latinas/os in the lands now known as the United States." In addition to having a paper published, each Student Scholar will receive a full scholarship to the Annual LatCrit Conference in Philadelphia in April as well as a full scholarship to the Critical Global Classroom, a summer study-abroad program in Chile and Argentina during the summer of 2004. In addition, each Student Scholar will receive a travel stipend of up to \$1,250. Applications must be postmarked or emailed by January 20, 2004.

American Indian Law Writing Competition - The University of Oklahoma College of Law is accepting papers on any issue concerning American Indian Law. Prizes of \$1,000, \$500, and \$250 will be awarded for first-, second-, and third-place entries, respectively. All entries must be postmarked first class no later than January 31, 2004.

Religious Freedom - The Alliance Defense Fund, Inc., is sponsoring the **2004 William Pew Religious Freedom Scholarship Competition**, which will award cash prizes of \$5,000, \$2,000 and \$500 for the top three papers that address "one or more legal issues justifying a perspective consistent with religious liberty, the sanctity of life and/or traditional values, including marriage as a uniquely being between one man and one woman, as advocated by the Alliance Defense Fund on its web site at www.alliancedefensefund.org." **Entries must be postmarked no later than April 1, 2004.**

Contemporary American Government and Society - The Pacific Legal Foundation's Program for Judicial Awareness announces its **Fifth Annual Student Writing Competition**. Entrants are required to write on one of three topics: the impact on Takings Clause jurisprudence resulting from the Supreme Court's decision in *Lucas v. South Carolina Coastal Council*, 505 U.S. 1003 (1992); the role of international law in

judicial interpretation of the United States Constitution; and the scope of the Commerce Clause in enforcement of Title VII of the Civil Rights Act. First-, second- and third-place awards of \$5,000, \$3,000 and \$1,500 will be made. Submissions must be postmarked no later than May 31, 2004.
