

## MARK YOUR CALENDAR

**Professor Cynthia Ward**, The 2002/03 Blackstone Lecturer, will present "Coercion and Choice in the Establishment Clause," on Thursday, February 27, 3:00 p.m., room 127. The lecture is open to the public so please plan to attend. A reception will follow in the Lobby.

The Establishment Clause is one of two First Amendment clauses that address the relationship between religion and government. In two controversial cases

last year – one challenging the Pledge of Allegiance and the other a school voucher plan in Cleveland – federal courts affirmed the importance of coercion in determining when government action has violated the Establishment Clause. In her lecture, Professor Ward will examine the core meaning of coercion, compare it with the conception of coercion that has appeared in the Supreme Court's recent Establishment Clause opinions, and suggest the proper role of coercion in a coherent Establishment Clause jurisprudence.

OLIVER HILL SCHOLARSHIP - The Oliver Hill Scholarship will be awarded to a student who is committed to the objectives, goals, and principles of the Black Law Students Association (BLSA) at William & Mary Law School. The recipient must demonstrate a commitment to personal excellence, social justice and advancing and protecting civil rights of all citizens. Students in good standing at the Law School, who demonstrate financial need, exhibit leadership abilities in the Law School or the community and display a record of public or community service are eligible. Interested students must apply for the scholarship by submitting two copies of the following to the Dean's Office by MARCH 15: resume, statement (no more than one double-spaced page) that describes how the student meets the criteria and an essay (no more than two double-spaced pages) on the topic "How Oliver Hill's achievements have had an impact on my life." Please be sure to submit all applicant materials by MARCH 15, 2003.

THE GILES SUTHERLAND RICH MEMORIAL SCHOLARSHIP — An award of \$10,000, in memory of Giles S. Rich, Circuit Judge, United States Court of Appeals for the Federal Circuit, will be given by the Federal Circuit Bar Association to a law student showing financial need, and who has demonstrated academic promise, either in undergraduate studies or in law school. Selection for the award will be based primarily

on a written submission of no more than one page setting out the applicant's financial need, any interests in particular areas of the law, and any qualifications for the award considered relevant by the applicant. The submission should also include all of the applicant's college and law school transcripts, and one-page curriculum vitae.
