

HUMAN RIGHTS ADVOCATE - Stephen Rickard, acting director of the Washington, DC, office of the Open Society Institute, will present a lecture titled "Doing Well by Doing Right: Values in American Foreign Policy and the Struggle against Terrorism" at *5:00 p.m. on Monday, November 14*, at William & Mary Law School in room 120. The talk is part of the distinguished lecture series sponsored by the Human Rights and National Security Law Program.

Rickard serves as acting director of the Washington, DC, office of the Open Society Institute, a nonpartisan public policy organization which focuses its work there on violations of civil liberties and criminal and civil justice reform. He previously worked as director of the Nuremberg Legacy Project, the Robert F. Kennedy Memorial Center for Human Rights, and of the Washington, DC, office of Amnesty International USA. He was senior advisor for South Asian Affairs at the U.S. State Department from 1994-96, and also, from 1989-94, was senior foreign policy advisor to Senator Daniel Patrick Moynihan and was a senior professional staff member on the Senate Foreign Relations Committee. During his time on Capitol Hill, he helped secure Senate approval for numerous treaties on international human rights and labor rights.

THOMAS SHAW, a managing attorney at the Trademark Office of the US Patent and Trademark Office (and the director of their internship program), will be speaking on his experiences at the Trademark Office and also past and current trends in Trademark law. *Wednesday, November 16 at 1:00 p.m. in room 124*. Deadline for "Early Decision" Public Interest and Government Summer 2006 Funding for 2Ls - Funding through six programs (Bell, Criminal Justice, Lambda, Virginia Law Foundation, Public Service Fund [PSF], and Williams) is available through an "early-decision" process, which gives 2-Ls the opportunity to know about funding decisions before the end of the fall semester. **The application DeadLine for "Early Decision" Funding is Friday, November 18 at 5:00 p.m.**

WRITING COMPETITIONS (see OCS for more info)

A Word on Writing Competitions - Throughout the academic year we receive announcements regarding essay competitions and invitations to submit papers for publication in law reviews and journals. This information is posted outside OCS. In addition to the intellectual and often economic benefits of these contests, the competitions are another way for you to demonstrate your legal writing abilities to employers. Because they are often sponsored by bar associations and other professional groups, they also provide excellent networking opportunities. Keep in mind that faculty members are a good source of ideas and guidance if you decide to participate. We have recently posted information regarding the following writing competitions:

Human Rights - The Willamette Journal of International Law and Dispute Resolution is sponsoring a writing competition on the topic "Conflicts: Human Rights and Humanitarian Law." Papers should address emerging issues in the relationship and/or inconsistencies in the fields of Human Rights and Humanitarian Law. The author of the winning entry will be awarded \$500 and publication in the journal. Entries must be received no later than January 16, 2006.

- Intellectual Property The Virginia State Bar Intellectual Property Section is sponsoring a writing competition for law students in Virginia which will award a single prize of \$4,000. Students may submit any article relating to intellectual property law issues or practice. Entries must be received by Thursday, January 20, 2005.
- Health Law Epstein Becker & Green, a national firm engaged in the practice of health law, announces its eighth annual Health Law Writing Competition for papers on current topics of interest relating to health law. Papers may address any traditional area of the law as applied to health care (e.g., antitrust, tax, corporate), or areas of law unique to health care (e.g., fraud and abuse, managed care, Medicare/Medicaid). First prize is \$4,000, second prize is \$2,000, and third prize is \$500. Competition entries are due January 27, 2006.
- Environmental Law A prize of \$5,000 will be awarded in the Roscoe Hogan Environmental Law Essay Contest for the best essay written on the topic "Corporate Charters The Right to Do Wrong? Investigating Legal Strategies to Revoke the Charters of Corporations that Pollute." The winner will also receive a free trip to Seattle to receive the award in person. Intent-to-Enter forms must be postmarked or faxed by January 31, 2006. Essays are due March 28, 2006. For more info, see www.roscoepound.org.
- Professional Liability The ABA Standing Committee on Lawyers' Professional Liability invites entries in the 2006 Bert W. Levit Essay Contest on the topic of the legal standard controlling legal malpractice claims brought by persons convicted of crimes. The author of the best essay will receive \$5,000 and a free trip to New York City. Entries must be postmarked by February 17, 2006.
