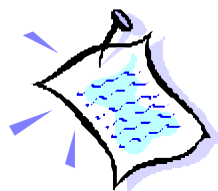

**ABA REACCREDITATION TEAM TO VISIT OCTOBER 18-21** - Be ready for some visitors! A seven-member team of lawyers and academics selected by the American Bar Association, will be on the premises October 18-21. They will visit classes; interview administrators, faculty, and student leaders; hold a town-meeting for students, and meet with main campus administrators to learn as much as they can about the nation's oldest law school today. They will have already digested hundreds of pages of data and a long Site Evaluation Questionnaire. They also will have read the Self-Study prepared by a faculty/student committee over the past year. We know our visitors will receive wonderful hospitality from everybody here.

The Site Visit Team will be headed by Dean Rebecca White of the University of Georgia Law School. Other team members are Professor Rita Reusch (University of Utah); Professor Stephen McAllister (University of Kansas); Professor Barbara Gilchrist (St. Louis University); Professor James Bowers (Louisiana State University); Provost Wallace Loh (University of Iowa); and Robert Fleishman (Steptoe & Johnson, Washington, DC).

After they leave campus, the Site Visit Team will write a comprehensive report for the ABA Accreditation Committee. We expect that committee will affirm our accreditation some time next spring or summer.

**THE 55<sup>TH</sup> ANNUAL WILLIAM & MARY TAX CONFERENCE** will take place November 12-13, 2009, at the Kingsmill Resort in Williamsburg, VA. The conference, titled "After the Party: Planning to Survive this Economy," is presented by the Law School and the Taxation Section of the Virginia State Bar. It includes panel discussions on the issues that a practitioner must address when working out a troubled business or real-estate project; a discussion of potential tax increases; how to convert economic losses into tax refunds from the IRS; an update on current events at OPR; estate planning for 2010 and beyond; a review of recent developments in federal income

tax; “hot topics” in Virginia taxation; a discussion of the implications of *Virginia Historic v. Commissioner*; and an examination of IRS audits of partnerships and S corporations.

Professor Eric Chason, director of the conference, said, “This year, we're starting a day early with our Primer on Partnership Taxation, which is being held at the law school itself.” This special pre-conference class, “Partnership Taxation 101: An Introduction to Subchapter K,” will take place on November 11 from 4 p.m. to 6 p.m.

**VIRGINIA BAR UPDATE** - The Application for the Virginia Bar Examination and the Applicant's Character and Fitness Questionnaire are available online through the Virginia Board of Bar Examiners web site at: <http://www.vbbe.state.va.us/forms.html> Students who expect to sit for the Virginia Bar Examination can file the Character and Fitness Questionnaire within the first 14 months of their law school career for a discounted rate. The Bar Application itself cannot be filed more than three months prior to sitting for the exam.

Those planning to sit for the Virginia Bar are forewarned that the Virginia Board of Bar Examiners requires applicants to take the Multi-state Professional Responsibility Examination (MPRE). There are several **Fellowship Programs** that provide stipends of up to \$3,600 for students who secure summer internships with employers who are unable to provide funding or can only provide partial funding. The availability of funds through William & Mary enhances your candidacy with employers. There is a one-page handout available on the display racks in OCS that describes William & Mary's various Fellowship Programs for the summer of 2010. Please feel free to include this flier with your resumes and cover letters to government and public service employers. This information is also available on OCS Resources for Students in Blackboard under "Government and Public Interest." In your cover letter, you may want to indicate that "William & Mary has several public interest [or government] summer funding sources, as detailed on the enclosed sheet." The application process for these fellowships is very competitive, and you must have a written offer of employment in order to apply for funding. **2Ls: please note the message below about the "early decision" process.**

**Deadline for "Early Decision" Public Interest and Government Summer 2010 Funding for 2Ls:** Funding through eight programs (Bell, Christopher Wren Association, Dean's Fellowships, Pinter Fellowships, Virginia State Bar Criminal Law Section, Virginia Law Foundation, Public Service Fund [PSF], and Williams) is available through an "early-decision" process, which gives 2Ls the opportunity to know about funding decisions before the end of the fall semester. **The application deadline for "early decision" funding is Friday, November 20 at 5:00 p.m.**

**The U. S. Department of State is significantly increasing** the number of foreign service officers it is hiring at the present time. Please find below information about **summer and post-graduate opportunities with the U.S. Department of State:**

**For 1Ls and 2Ls:** If you're interested in the State Department's summer 2010 internship program or serving as a foreign service officer, visit



<http://careers.state.gov/>. The deadline to apply for the Department's summer internship program is **November 2**.

**1Ls please note:** Although 1Ls are required to wait until after December 1 to apply for jobs according to the NALP guidelines, an exception is made for the internship program with the Department of State since this internship is not directly law related.

**For 3Ls:** The process for registering for the foreign service exam and finding out about upcoming test dates are explained at the following website: <http://careers.state.gov/officer/employment.html>. It is not too early to start the application process for foreign service positions in order to begin after you graduate in 2010.

Also, on **Thursday, October 15** at 12:50-1:50PM in Room 133, OCS will sponsor **Careers in the U.S. Department of State**. Steve Kelly, Diplomat in Residence at Duke University and a Foreign Service Officer with the State Department for many years, will be the guest speaker.

The **Presidential Management Fellows (PMF) Program** is a two-year, paid, leadership development program that provides opportunities for freshly minted graduates of law, public policy, business, and other graduate programs to work in the federal government. Presidential Management Fellows impact public policy, receive competitive pay, benefits, and career advancement through positions with a federal agency. Fellows are hired to work on domestic and international issues in public administration, technology, science, criminal justice, health, financial management, and many other fields. **Historically, William & Mary graduates have been very successful in being hired into the PMF Program.**

Interested students must apply to the program online. **The PMF Program application process will be open for two weeks from October 1 to October 15, 2009. Recruitment, application, and nomination information and resources are available at [www.pmf.opm.gov](http://www.pmf.opm.gov).**

Additionally, OCS is organizing a program, "**Public Policy Opportunities in the Federal Government: The Presidential Management Fellows Program,**" on **Tuesday, October 6, at 1 p.m. in Room 141**.
